GENERAL TERMS AND CONDITIONS

All attendees under the age of 18 must bring a copy of these terms, signed by their legal guardian, to the event. Failure to do so will result in you not being able to participate and no refunds will be made. LAN IN THE HIGHLANDS 2011 does not permit or condone any type of illegal activity. This activity includes but is not limited to, the unlicensed copying of software, MP3s or distribution of pornographic material. Each machine is each player's personal responsibility/liability. If you are caught distributing or acquiring any of the above you will be ejected with no refund. Our network is for gaming, not propagating the use/distribution of illegal software/content. Consumption of illegal drugs is expressly prohibited, regardless of event location. This includes but is not limited to the building proper, parking lots, bathrooms, dumpsters, roof-tops, etc. Consumption of alcohol is expressly prohibited by those who are under the age of 21, or do not show proper valid ID. Stealing is also grounds for ejection. If you are caught stealing the authorities will be notified. We will also provide any and all information we have to the authorities to expedite prosecution. We're all here to have a good time with our OWN equipment. LAN IN THE HIGHLANDS 2011, the organizers and the owner of the location of the event are not responsible for damaged, lost or stolen property of any sort either at or going to or from the event. **By attending our event you agree to allow us to use any video, pictures or audio captures of you and your handle/nickname for the purpose of publicity. If for any reason you would not like us to use any of the above, please notify us in writing with your signature at the bottom.**

PARTICIPATION GUIDELINES:

- Participants WILL conduct themselves in a professional and sportsmanlike manner.
- Participants will be available on time (as indicated in the schedule at the event).
- Participants must be ready to play at the start of their match.
- If necessary, the winners will be available as indicated by Sponsors after the Tournament for promotional purposes.
- Failure to follow these guidelines will result in immediate disqualification

CHEATING:

Cheating will NOT be tolerated. Cheating is punishable by immediate disqualification from the Tournament and removal from the Event. An example of this would be hacking the server in some way to give you an unfair advantage in game. Refunds will not be awarded to any individual found to be cheating in any way.

ACTS OF VIOLENCE:

Acts of violence will NOT be tolerated. Violence will be deemed immediate disqualification from the Event and removal from the Premises. Violence is defined as physical force employed so as to violate damage or abuse (that can include behavior or actions.) MFA Administrators/Sponsors has all rights on what is considered a "Violent Act" or not. Refunds will not be awarded to any individual who engages in acts of violence.

OFFICIALS:

LAN Party officials along with Sponsors execute all facets of the LAN Party and Tournament. LAN IN THE HIGHLANDS 2011 Administrators/Sponsors reserve the right to require any Participant to replay any match for any reason, at their sole discretion and to disqualify any participant who fails to follow the Official Rules, who makes any misrepresentation relative to the Tournament and/or the redemption of prizes, who tamper with the entry process or the operation of the Tournament or Web Site, who acts in violation of the [Official Rules](#), who acts in an unsportsmanlike or disruptive manner or who acts with intent to annoy, abuse, threaten or harass any other person(s). To ensure that players have played according to the Official Rules, Tournament Officials will review ALL game play during the Tournament. Decisions by Tournament officials are FINAL. All prizewinners will be identified on site at the Event.
